## FOURTH AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

THIS FOURTH AMENDMENT to the Agreement for Services of Independent Contractor (hereafter the "Fourth Amendment"), is made and entered into this 10<sup>th</sup> day of November 2020, by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter "County") and Aramark Correctional Services, LLC (hereafter "Contractor"). For purposes of this Fourth Amendment, the County and Contractor shall be referred to collectively as the "Parties."

WHEREAS, Parties entered into an Agreement for Services of Independent Contractor with an effective date of May 17, 2016, (hereafter the "Agreement"), by which Contractor agreed to provide commissary services to Sheriff's Office Main Jail inmate population; and

WHEREAS, The Third Amendment to this Agreement approved by the Board of Supervisors on, July 1, 2020, provides that the term of the Agreement shall end on September 30, 2020;

WHEREAS, the Parties desire to further amend the Agreement to extend the term on a month-to-month basis not to exceed 90-days and expiring on December 31, 2020.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, it is mutually agreed upon as follows:

- 1. The end of the term of the Agreement, Section 4, Term, is extended on a month-to-month which shall not exceed December 31, 2020. Without penalty, County reserves the right to terminate the services defined in this Agreement upon the provision of a 30-day written notice from County to Contractor at any time during the duration of this extension to the term.
- 2. In an amount not to exceed \$221,000.00.
- 3. In all other respects, the terms and conditions of the Agreement shall continue unchanged and in full force and effect.

IN WITNESS WHEREOF, the Parties hereto have executed this Fourth Amendment to be effective on the date executed by the County.
