## AMENDMENT NO. 1 TO THE TRANSFER AGREEMENT FOR THE SANTA MARIA FAMILY MEDIATION FACILITY

THIS AMENDMENT NO. 1 TO THE TRANSFER AGREEMENT FOR THE SANTA MARIA FAMILY MEDIATION FACILITY (this "Amendment") is made and entered into this \_\_\_\_ day of January, 2010 by and between the County of Santa Barbara ("County"), whose present address is 105 E. Anapamu Street, Santa Barbara, CA 93101, Attention: Assistant Director, Financial, and the Judicial Council of California ("Council"), Administrative Office of the Courts (together with the Council, the "AOC"), whose present address is 455 Golden Gate Avenue, San Francisco, CA 94102, Attention: Assistant Director, Office of Court Construction and Management, with respect to the following facts:

## RECITALS

- A. The AOC and the County have entered into that certain Transfer Agreement for the Transfer of Responsibility for Court Facility pertaining to the Santa Maria Family Mediation Facility, which has an Effective Date of December 16, 2008, and is attached hereto as Attachment 1 ("TA");
- B. The TA provides a deadline by which the County is to enter into and obtain certain fully-executed Construction Agreements to facilitate the County's construction of the New Clerk's Building within the Santa Maria Courts Complex; and
- C. The Council and the County now wish to amend the TA to extend the County's deadline for entering into and obtaining the fully-executed Construction Agreements, as set forth in this Amendment.

NOW, THEREFORE, the County and the Council do hereby agree as follows:

- 1. Extension of Deadline to Obtain Construction Agreements. The words "December 31, 2009" in section 4.3, section 5.2.1, and section 5.2.2 of the TA are hereby deleted and are replaced, in each such section, with the words "June 30, 2010", thereby extending the County's deadline for entering into and obtaining the fully-executed Construction Agreements for the New Clerk's Building from December 31, 2009 to June 30, 2010.
- 2. <u>No Other Changes</u>. Except as it is expressly amended pursuant to this Amendment, the TA remains in full force and effect as originally signed and approved by the Council and the County.

- 3. <u>Construction</u>. The capitalized terms used in this Amendment and not otherwise defined herein will have the meanings given to them in the TA.
- 4. <u>Effective Date</u>. The Parties agree that this Amendment relates back to and is effective as of the Effective Date, as though this Amendment had been signed by both Parties on the Effective Date.
