Title: Budget expenditure and revenue for Agricultural Tiered Permitting Ordinance Amendments

Budget Action: Increase appropriations of \$170,000 in Planning and Development General Fund for Services and Supplies funded by a release of Committed Planning/Development Projects fund balance.

Justification: Approval of this budget revision in the amount of \$170,000 will provide budget authorization to enter into an agreement for services with a consultant to prepare amendments to the County Land Use and Development Code (LUDC) and Coastal Zoning Ordinance (Article II) for the Agricultural Tiered Permitting project. Project costs are funded by General Fund Contribution (for Salaries and Employee Benefits) and, pending approval of this budget revision, Committed Fund Balance available for the Long Range Planning Division (for Services and Supplies-Professional & Special Service).
