FOURTH AMENDMENT Effective July 1, 2019

THIS IS THE FOURTH AMENDMENT (hereafter referred to as Fourth Amendment) to the Agreement for STEMI Receiving Center Designation, by and between the County of Santa Barbara (COUNTY) and Santa Barbara Cottage Hospital (HOSPITAL), commencing on July 1, 2010 (the "Agreement").

WHEREAS, the Agreement is effective through June 30, 2019; and

WHEREAS, the parties desire to amend the Agreement to extend the term and adjust compensation; and

WHEREAS, this Fourth Amendment incorporates the terms and conditions set forth in the Agreement, First Amendment, Second Amendment, and Third Amendment approved by the County of Santa Barbara.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. <u>Definitions.</u> Capitalized terms used in this Fourth Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

2. Amendments.

- a. The Agreement is amended as follows:
 - 4. <u>TERM.</u> The term of this Agreement shall be for the period of July 1, 2019 through December 31, 2019.
 - 5. <u>FEES.</u> HOSPITAL agrees to pay COUNTY for services provided under the terms of this Agreement: *\$14,557* for the extended six month term for maintaining the STEMI program. This service charge shall be paid in full by July 31, 2019.

- 3. <u>Counterparts.</u> This Fourth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
- 4. <u>Effectiveness of Agreement.</u> Any and all other terms and provisions of the Agreement, as amended, remain in full force and effect.
