## SIXTH AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

THIS IS THE SIXTH AMENDMENT (hereafter "Sixth Amendment for Services) to the Agreement for Services of Independent Contractor (herafter "Contract"), made by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter "COUNTY"), and Big Green Cleaning Company, A Santa Barbara Company (hereafter "Contractor").

WHEREAS, the current contract amount is Eight Million, Three Hundred and Eight Four Thousand, Five Hundred and Seventy Eight (\$8,384,578.00). The sixth amendment totals Five Million, One Hundred and Fifty One Thousand, Nine Hundred and Seventy Four (\$5,151,947.00), creating a total Contract amount that shall not exceed Thirteen Million, Five Hundred Thirty Six Thousand, Five Hundred Twenty Five Dollars (\$13,536,525.00);

**WHEREAS**, the parties desire to amend the Contract to increase the Contract amount by Five Million, One Hundred Fifty One Thousand, Nine Hundred Forty Seven Dollars (\$5,151,947.00) to an amount not to exceed Thirteen Million, Five Hundred Thirty Six Thousand, Five Hundred Twenty Five Dollars (\$13,536,525.00); and

WHEREAS, this Sixth Amendment incorporates the terms and conditions set forth in the Agreement except as modified by this Sixth Amendment.

**NOW THEREFORE,** for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR hereby agree to amend the Agreement as follows:

1. <u>Definitions.</u> Capitalized terms used in this Sixth Amendment, to the extent not otherwise defined herein shall have the same meaning as in the Agreement.

#### 2. Amendments.

- a. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, not to exceed Thirteen Million, Five Hundred Thirty Six Thousand, Five Hundred Twenty Five Dollars (\$13,536,525.00), as per the payment agreement in Attachment 1.
- b. For CONTRACTOR services to be rendered under this agreement, the contract with the CONTRACTOR will include two options for 2-year extensions. The approval of this amendment will exercise the final option and will increase funding for services through December 31, 2022.
- **3.** <u>Counterparts.</u> This Sixth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between parties.

4. It is expressly understood that in all other respects, said terms and conditions of the Contract shall be in full force and effect. This Sixth Amendment to Agreement for Services of Independent Contractor between the County of Santa Barbara and Big Green Cleaning Company.
