**THIS IS THE FIFTH AMENDMENT** (hereafter “Fifth Amendment for Janitorial Supplies and On-Demand Services) to the Agreement for Services of Independent Contractor (hereafter “Contract”), made by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter “COUNTY”), and Big Green Cleaning Company, A Santa Barbara Company (hereafter “Contractor”).

**WHEREAS**, the current Contract amount is Seven Hundred Sixteen Thousand Nine Hundred Forty Six (\$716,946.00);

**WHEREAS**, the parties desire to amend the Contract to increase the Contract amount by One Million Two Hundred Fifty Two Thousand Dollars (\$1,252,000.00) to an amount not to exceed One Million Nine Hundred Sixty Eight Thousand Nine Hundred Forty Six Dollars (\$1,968,946.00); and

**WHEREAS**, this Fifth Amendment incorporates the terms and conditions set forth in the Agreement except as modified by this Fifth Amendment.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR hereby agree to amend the agreement as follows:

1. **Definitions.** Capitalized terms used in this Fifth Amendment, to the extent not otherwise defined herein shall have the same meaning as in the Agreement.
2. **Amendments.**
  - a. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, not to exceed One Million Nine Hundred Sixty Eight Thousand Nine Hundred Forty Six Dollars (\$1,968,946.00 as per the payment agreement in Attachment 2.
  - b. For CONTRACTOR services to be rendered under this agreement, the contract with the CONTRACTOR will include two options for 2-year extensions. The approval of this amendment will exercise the final option and will increase funding for services through December 31, 2022.
3. **Counterparts.** This Fifth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between parties.
4. It is expressly understood that in all other respects, said terms and conditions of the Contract shall be in full force and effect.
