Justification: This BJE will streamline the AB109 CCP revenue distribution for the Sheriff's Office to run through the Probation Department and be consistent with the

revenue and claim process with the Public Defender's Office, the District Attorney's Office, and Behavioral Wellness Department. With the Probation Department acting as the lead department for AB109 CCP, this new process allows Probation to manage any unspent Restricted Fund Balances on behalf of the CCP and eliminates the need for multiple departments to create fiscal year end fund balance BJEs. This also creates efficiencies between the Sheriff's

Office, Probation Department, and the Auditor Controller's Office.
