## **Recommended Actions:**

That the Board of Supervisors:

- a) Authorize the Director of Public Works to accept the highest Public Auction offer to purchase County surplus off-road heavy equipment and on-road vehicles at a Caterpillar sponsored auction and Public Surplus auction;
- b) Authorize the Purchasing Manager to prepare Bills of Sale and complete the transaction; and
- c) Determine that the proposed actions are not a project under the California Environmental Quality Act (CEQA) pursuant to Section 15378(b)(5) of the CEQA Guidelines, because they consist of administrative activities of government that will not result in direct or indirect physical changes in the environment.

## **Summary Text:**
