On February 9, 2021, set a hearing for March 2, 2021 to consider Case No. 19APL-00000-00026, an appeal of the Planning Commission's August 2, 2019 approval of the Ellwood Quarry Revised Conditional Use Permit and Reclamation Plan, Case Nos. 18RVP-00000-00016 and 17RVP-00000-00082.

On March 2, 2021, staff recommends that your Board take the following actions:

- a) Deny the appeal, Case No. 19APL-00000-00026.
- b) Make the required findings for approval of the project, including California Environmental Quality Act (CEQA) findings;
- c) After considering the environmental review documents (Addendum together with the previously certified Environmental Impact Report 87-EIR-3), determine that as reflected in the CEQA findings, no subsequent Mitigated Negative Declaration or Environmental Impact Report shall be prepared for this project.
- d) Grant *de novo* approval of the project, Case Nos. 17RVP-00000-00082 and 18RVP-00000-00016, subject to the conditions of approval.

The project site is identified as Assessor's Parcel Number 079-100-017, located at 1300 Ellwood Ranch Road, approximately one-half mile north of Cathedral Oaks Road near the western end of the City of Goleta, within the Third Supervisorial District.
