Justification: This Budget Revision Request increases appropriations in the Planning and Development Department's Planning and Development Fund for consultant

services required for the preparation of a departmental strategic plan. These consultant services will be funded by unspent funds allocated to the department

for the Orcutt Community Plan Amendment/Union Valley Parkway Road Connection project.

In FY 2018-19 and FY 2019-20, the Board of Supervisors (BOS) approved funding for the Planning and Development Department to prepare an amendment to the Orcutt Community Plan. On December 15, 2020, the BOS made the findings for approval, adopted Final Initial Study - Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program, and adopted a resolution to approve the amendment to the Orcutt Community Plan. The initial cost estimates for the preparation of the amendment factored in the preparation of an Environmental Impact Report. However, a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program were required, which reduced the project's costs.
