### **Recommended Actions:**

That the Board of Supervisors:

- A. Approve, ratify, and authorize the Department of Behavioral Wellness Director to execute twelve grant agreements (No. CA20MAT214-225) with Sierra Health Foundation: Center for Health Program Management, a California nonprofit public benefit corporation that is assisting the Department of Health Care Services (DHCS) with the administration of grant funds, accepting a total of \$522,000 to support behavioral health telehealth infrastructure improvement activities due to the impact of COVID-19 for the period of 9/1/2020 through 6/30/2021;
- B. Delegate to the Department of Behavioral Wellness Director the authority to execute subsequent reports pursuant to Exhibit II Program and Financial Reporting Requirements of the grant agreements and to execute immaterial amendments to the grant agreements that do not change the amount or substantive terms of the grant agreements, subject to the Board's ability to rescind the delegated authority at any time;
- C. Approve Budget Revision Request (BJE #0007294) increasing appropriations of \$472,000 in Behavioral Wellness Department, Mental Health Services Act Fund, for S&S (\$344,100) and Capital Assets (\$127,900) and increasing appropriations of \$50,000 in Behavioral Wellness

- Department, Mental Health Services Fund, for S&S (\$18,100) and Capital Assets (\$31,900). A total of **\$522,000** in unanticipated revenue from the DHCS Telehealth Grant Award; and
- D. Determine that the above actions are government fiscal activities or funding mechanisms which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA guidelines.

## **Summary Text:**

Utilizing Substance Abuse and Mental Health Services Administration (SAMHSA) funds, the Department of Health Care Services (DHCS) developed a grant program to assist behavioral health providers with the transition to telehealth services in response to COVID-19. Behavioral Wellness applied for grants to support 12 of our mental health locations throughout the County. Behavioral Wellness was awarded grant funding totaling \$522,000 to enhance our telehealth capabilities, and approval of the recommended actions will allow acceptance of grant awards and implementation of telehealth infrastructure.

## **Background:**

Without intervention, the disruption presented by COVID-19 will pose risks to treatment for individuals with substance use disorder and mental health disorders. Therefore, DHCS developed grant funding to enhance telehealth capacity of behavioral health providers, including creation of telehealth centers to be accessed by individuals who do not have regular, confidential access to technology. Eligible applicants included community-based mental health and substance use disorder providers and County Behavioral Wellness departments and providers could apply for up to \$50,000 per site for costs, including, laptops, desktops, monitors, and internet subscriptions such as Zoom. Sites could also apply for up to 10% of the total cost to cover PPE equipment. Extra scoring points may be added for providers in counties with the highest mortality rates related to substance use disorders and mental health disorders and for providers who serve patients in predominantly rural areas.

Grant funding will allow Behavioral Wellness to acquire additional resources necessary to enhance telehealth services for staff and clients. Staff will be provided with equipment necessary to facilitate telehealth mental health services regardless of whether they are in the field, at home, or in the office. Equipment may include laptops, monitors, and video conferencing licenses. Additionally, funding will also be utilized to convert office space and conference rooms into telehealth centers where clients and staff can engage in individual and small group sessions within COVID-19 social distancing restrictions.

Narrative: This Board letter seeks authorization for the Department of Behavioral Wellness Director to sign twelve grant agreements with Sierra Health Foundation: Center for Health Program Management accepting DHCS grant funds in the amount of \$522,000. This is a one-time funding opportunity.

## **Key Contract Risks:**

The funding is subject to congressional appropriation of funds. If the funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, DHCS has the option to either cancel this Contract with no liability occurring to DHCS, or offer an amended agreement to Contractor to reflect the reduced amount. It also passes on to the County the responsibility to repay any audit exception taken by the Federal government or the California State Auditor. The contract also imposes procedural and reporting requirements that Behavioral Wellness currently implements, that could be subject to audit in the future.
