The Engineer is authorized to order, as change order work, changes and additions to the work being performed under this contract in an amount not to exceed <u>\$51,694.25</u> (Contingency) in accordance with California Public Contract Code Sections 20142 and 20395, as applicable, to be paid as provided in the Contract Documents.

2. In all other respects, the Agreement shall remain in full force and effect.
