HANNAH-BETH JACKSON

AS A PIONEER FOR WOMEN AND HER DEDICATED SERVICE TO GENDER EQUITY

WHEREAS, Hannah- Beth Jackson has served as a role model to girls and women throughout our county, state, nation, and around the world, and has supported and encouraged countless other women to run for higher office and serve in leadership and executive roles; and

WHEREAS, first she began her distinguished career as a prosecutor in the Santa Barbara County District Attorney's office, and subsequently became a managing attorney practicing family-law in Santa Barbara and Ventura Counties; and

WHEREAS, from 1998 to 2004 Hannah- Beth Jackson represented part of Santa Barbara County in the 35th Assembly District and authored many bills signed into law that moved women forward and she continued her time at the state and went on to serve as the Santa Barbara County District 19th State Senator from 2012-2020; and

WHEREAS, as a California Senator, Hannah-Beth Jackson authored the California Fair Pay Act, landmark legislation strengthening California's equal pay law, authored SB 826, the first-in-the-nation legislation requiring more women on corporate boards, and SB 1383 which extended job-protected maternity and paternity leave for California families; and

WHEREAS, during her time in the Senate she held the position as Chair of the Legislative Women's Caucus from 2015 to 2016 and her track record during her time in the Legislature brought her national recognition by the Huffington Post which named her one of 11 women in the county "blazing new trails"; and

WHEREAS, Hannah-Beth Jackson has received Legislator of the Year awards from a wide range of organizations and is the recipient of the prestigious California Women Lawyer's Fay Stender Award, given annually to an attorney who serves as a role model for women. An advocate for justice for women, children, and victims of crime for more than three decades, she helped establish the local organizations that became known as Domestic Violence Solutions and The Coalition Against Gun Violence:

WHEREAS, it is likely that Hannah-Beth Jackson's lifelong work of advocating for women's equality and those most overlooked and underserved started because despite being the best player in the neighborhood, she was discriminated against playing Little League Baseball just because she was a girl; and

WHEREAS, Hannah-Beth Jackson continues to inspire women of all ages to creating a better world for generations to come;

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDERED AND RESOLVED, that the Santa Barbara County Board of Supervisors recognize Hannah-Beth Jackson for her distinguished career in service to the women of the beautiful State of California.

WHEREAS, she was inspired and took it upon herself to create a Freedom 4 Youth Advocates at UCSB to support college students as mentors for youth in the juvenile justice system; and

WHEREAS, once she finished her time at UCSB with her Bachelor's in Cultural Anthropology, she went on to gain her Masters of Social Work from California State University Fullerton, being awarded the Outstanding Master's Project from her graduating class for her research which explored gender-specific social-environment effects on self-regulatory risk factors of delinquency among youth in the juvenile justice system; and

WHEREAS, Ms. Torres's research was also recognized with the California Social Work Education Center research award and she was invited to present her findings at the Society for Social Work Research National Conference in Washington, D.C.; and

WHEREAS, she continues her dedication to our beloved community as Program Director/Co-Founder with Freedom4Youth in Santa Barbara and as a Clinical Supervisor working with youth in need at Casa Pacifica; and

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDERED AND RESOLVED that this Board of Supervisors of Santa Barbara County recognizes Meghann Torres, as the First District Commission for Women Service Award Recipient.

WHEREAS, Lisa, together with her husband, introduced Project Lexi Brown Foundation in 2017, on the one year anniversary of Lexi's passing, in order to continue their daughter's determination in making a difference in the lives of those families who have a child diagnosed with cancer; and

WHEREAS, Beginning in 2015, Lisa, with friends and Lexi by her side, helped to start the Bald For Lexi fundraiser - benefiting St. Baldrick's Childhood Cancer Research - and raised a total of nearly \$300,000 during 5 events in Santa Maria; Lisa was even a participant in 2018 when she shaved her head while sporting dyed NEON purple hair (Lexi's favorite color); and

WHEREAS, Since 2016, Lisa has partnered with the Santa Maria Elks Lodge non-profit, the Golden Circle of Champions (inspired by Lexi), as Committee Chair to bring a true cowboy adventure, including dinner, rodeo gear and all-around VIP event, to celebrate brave, young warriors and their families and Lisa has been instrumental in taking the event to the National Finals Rodeo (NFR), in Las Vegas, where children from all over the country have enjoyed the festivities; and

WHEREAS, Lisa Brown has dedicated countless hours to cancer families and, while she mourns the loss of her daughter, she strives to emulate Lexi's strength to continue Project Lexi Brown Foundation and her legacy of making a difference to those in need through providing memories, offering a heartfelt smile, advice, or just listening and offering hope when it may seem so far away;
