#### That the Board of Supervisors:

- A. Find the bid of California Coastal Development, Inc. for 2009 ARRA Miscellaneous Concrete Repair in Old Town Orcutt, in the Fourth Supervisorial District of Santa Barbara County, County Project No. 820620 to be nonresponsive;
- B. Award the construction contract in the amount of \$ 158,052.75 to the lowest responsive bidder, Elevation General Engineering Contractors, Inc. (A local vendor) 2333 A Street, Santa Maria, CA 93455, subject to the provisions of documents and certification, as set forth in the plans and specifications applicable to the project and as required by law;
- C. Authorize the Chair to execute the construction contract upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller, and Risk Manager, or their authorized representatives; and
- D. Approve a contingency fund in the amount of \$15,805.28 for 2009 ARRA Miscellaneous Concrete Repair in Old Town Orcutt, in The Fourth Supervisorial District of Santa Barbara County, County Project No. 820620.

#### **Summary Text:**

On March 4, 2010, the Public Works Department received nine (9) bids for 2009 ARRA Miscellaneous Concrete Repair in Old Town Orcutt, in the Fourth Supervisorial District of Santa Barbara County, County Project No. 820620. The lowest bid was submitted by California Coastal Development, Inc. in the amount of \$139.849.50, which is 38.8% under the Engineer's Estimate. However, California Coastal Development's Exhibit 15-H Underutilized Disadvantaged Business Enterprises (UDBE) Information – Good Faith Efforts Submittal showed that their bid requests for UDBE contractors participation was published on the same day of the bid opening, giving potential subcontractors little, if any, time to respond. In addition, other sections of Exhibit 15-H were incomplete or missing information. County specifications, based on California Department of Transportation (Caltrans) and FHWA requirements, state that contractors must show adequate good faith efforts are made to meet County UDBE goals. Public Works Staff has deemed this bid to be nonresponsive based on this finding.


Therefore, the lowest responsive bid was submitted by Elevation General Engineering Contractors, Inc., in the amount of \$158,052.75, which is 19% below the Engineer's Estimate. This low bid can be attributed to the favorable bidding climate that currently exists as shown by the multiple bids received. Public Works staff performed analysis of the bid and determined that it is responsive and reasonable, and recommends awarding this contract to Elevation General Engineering Contractors, Inc. This project was bid in accordance with the Public Contract Code, which requires awarding to the lowest responsive bidder.

This project provides the first implementation of the Old Town Orcutt streetscape plan and will be used as a benchmark for future development and circulation improvements in the area. It includes reconstructing the intersection of Clark Avenue and Gray Street in unincorporated Old Town Orcutt. Construction consists of replacing four curb ramps with new bulb outs with planter areas, building decorative concrete crosswalks, grinding and paving parts of Clark Avenue and Gray Street, and replacing curb, gutter and sidewalk. The project will improve vehicle, bicycle, and pedestrian circulation, ADA access and safety.
