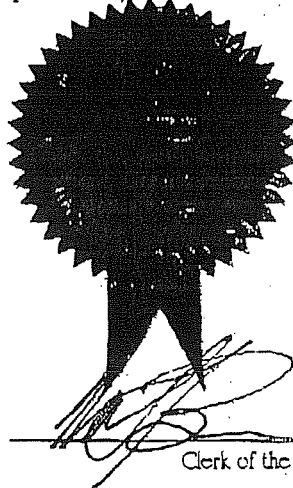

These three brave men entered a burning trailer home and worked in tandem to rescue an elderly, handicapped woman who was trapped there. These officers typify the police motto of "To Protect and To Serve"; risking their own lives to save another.

The 4th winner is Sr. Airman Talbert R. Kneppshield from the Vandenberg AFB, 30th Logistics Readiness Squadron, Vehicle Operations Flight. A registered Bone Marrow donor, Sr. Airman Kneppshield found out while deployed in Iraq he was a match for a patient in the U.S. With the help of the Air Force and the Army, he was able to return to the U.S. and undergo the procedure. The transplant was successful and Sr. Airman Kneppshield returned to Iraq to finish his deployment. Through his selfless sacrifice not only to his country, but to the bone marrow recipient, Sr. Airman Kneppshield epitomizes the Air Force core value of "Service Before Self", and;
