



## **Background on Measure A**

- In November 2008, the voters approved Measure A with 79% of the votes.
- Measure A continues the ½ percent local sales tax for Transportation Improvements for 30 years.
- The revenues generated countywide by Measure A will be distributed according to the voter approved investment plan.
  - A portion of the revenues will go to the widening of Highway 101 Widening
  - The remaining funds are divided equally between North and South County
  - > 65% of the North County funds are for Local Streets and Roads
  - 52% of the South Coast funds are for Local Streets and Roads

## **Differences between Measure D and Measure A**

- Local Agencies received 70% of the total Measure D revenues; with Measure A Local Agencies will receive approximately 17% less revenues
- Measure A Maintenance of Effort is based on Discretionary funds received by the Department in FY07/08. MOE will be adjusted annually by the change in retail activity
- Measure A requires the County expend 10% of our funding on Alternative Transportation

## •Priority #2:

## Five Year Program of Projects


- Two Programs of Projects are required for the County


