Recommended Actions:

That the Board of Supervisors on May 18, 2021 set a hearing for June 15, 2021 for the first reading of 21ORD-00000-00004 (Attachment A), amending Chapter 10 of the Santa Barbara County Code, as follows:

- a) On June 15, 2021, approve the introduction (first reading) of an Ordinance, Case No. 21ORD-00000-00004 (Attachment A), amending Chapter 10 of the Santa Barbara County Code, Building Regulations, adopting the Appendix O, Emergency Housing of the 2019 California Building Standards Codes with local amendments; and
- b) Read the title of the Ordinance and waive full reading of the Ordinance; and
- c) Continue the hearing to the Administrative Agenda of 6/22/2021 to:
 - i. Consider and approve the adoption (second reading) of an Ordinance amending Chapter 10 of the Santa Barbara County Code, Building Regulations; and

- ii. Determine that this ordinance amendment is exempt from the California Environmental Quality Act pursuant to CEQA Section 15268, 15301, 15302, 15303, 15304, 15311 and 15327.

Summary Text:

This agenda item introduces and schedules a public hearing for June 15, 2021 for the adoption of the Emergency Housing Codes, Appendix O of the 2019 California Building Standards Codes for consideration by the County Board of Supervisors. Several amendments to the code are proposed to provide more flexibility in acquisition and deployment of available emergency shelter structures.
