Title: BSCC Proposition 64 Public Safety & Health Grant

Budget Action: Increase Appropriations of \$40,964 in the Behavioral Wellness Department, Alcohol and Drug Programs Fund, for Salaries and Benefits (\$36,019) and

Service & Supplies (\$4,945) funded by the Proposition 64 Public Safety & Health Grant Grant revenue from the California Board of State and Community

Corrections (BSCC).

Justification: Proposition 64 Public Health and Safety Grant uses funding from the cultivation and retail sales of cannabis and cannabis products. Santa Barbara County

was eligible for funding since we do not ban the indoor or outdoor cultivation of cannabis, nor do we ban retail sales of cannabis and cannabis products.

Behavioral Wellness has been awarded \$959,895 for the period of May 1, 2021 through April 30, 2024.

According to Lucille Packard Foundation, Santa Barbara County has one of the highest cannabis youth use rates in the State.

Based on this need, Behavioral Wellness Department's Alcohol and Drug Program (ADP) will implement a program focused on cannabis education, prevention and early intervention. Behavioral Wellness will collaborate with schools to provide a foundation for Student Assistance Programs (SAP) which will provide a comprehensive approach to primary and secondary prevention, support groups, screening, care coordination, and Services, Brief Intervention and
