Approve the Statement of Final Quantities in the amount of \$69,733.66, for work performed, and materials supplied by the Contractor, NOCIS General Engineering (a local vendor), 1745 Viborg Road, Santa Ynez, CA 93436, for the Construction of Culvert Repairs and Gabion on Stagecoach Road, County Project No. 862263.

Summary Text:

This project consisted of repairing the culvert on Stagecoach Road at Mile Post 3.5, including the construction of a pipe riser with a debris rack cage to protect the culvert inlet, and the reconstruction of the outlet area with a gabion wall (a woven wire basket filled with rock).

The Director of Public Works accepted this project as complete on May 15, 2009. The project was completed on time and under budget.

The Public Works Department and County Counsel have executed a Settlement Agreement in the amount of \$5,465.03, with United Rentals Northwest, a supplier to NOCIS General Engineering. The Contractor failed to pay for services and filed for bankruptcy shortly after completing this project, which resulted in United Rentals Northwest issuing a Stop Work Order Notice to the County for non-payment. The Settlement Agreement relieves the County of any liability for payment.

The \$5,465.03 paid to United Rentals Northwest was the amount held in the contract retention. No additional funding was expended.

Background:

At Milepost 3.5, the inlet to a 24-inch culvert was completely plugged, due to a rock fall event during the 2005 Winter Storms. Upon clearing, it was discovered that the pipe had badly deteriorated, and the roots of a nearby tree were interfering with the outlet. The outlet of the culvert coincides with an over-side drain that was being undermined due to the erosion of the soil, lack of water dissipation at the outlet area, and the steepness of the embankment. In removing the rock debris from the inlet, the concrete inlet headwall was damaged. At Milepost 3.0, a culvert inlet area was plugged with rock and wood debris that had formed a small dam. This caused storm water to rise to the height of the roadway, flow across the road and down the shoulder. During the removal of the impounded water and debris, the inlet to this culvert was damaged.

This project was approved by the Board as part of the Five Year Capital Improvement 2007-2012 for the County of Santa Barbara, as shown on Page B-142.

Fiscal and Facilities Impacts:

The total construction contract cost was \$69,733.66, which includes \$5,465.03 paid as part of the Settlement Agreement. State Office of Emergency Services (OES) funded 11.47% (\$7,998.46), and the remaining 88.53% (\$61,735.20) was funded by the Federal Highways Administration (FHWA).
