I am writing to you as a County Supervisor to request that you use cannabis tax income revenue paid to the country to fund an effective cannabis compliance team. You appear to have ignored Chief Deputy Bonner's presentation on YouTube (https://youtu.be/dRL35AJOALI at mark 5:45-5:49). Perhaps it is time you or your staff had a look at it. It is only five minutes long. You, as Supervisors, have taken, as part of your oath when you were sworn in, to "provide quality public services to the people of Santa Barbara county in response to their need for a healthy, safe and prosperous environment". But you have failed to note the following points —

- The county is aware and has been advised by The Sheriff's department that the standard of service of an understaffed Cannabis Compliance Team grossly deviates from the reasonable expectations of the public.
- It was stated during the 4-12 hearing by Chief Deputy Bonner that of the 108 growers 50 percent claimed no Income or did not file at all.
- If the Compliance Team had enough manpower they would be able to monitor applicants growers (whether compliant or not) and with site Inspections they could clamp down on the 50% not filing and not claiming Income.

Since we have money coming in from at least some of the cannabis growers in our county, it seems relatively simple to take the top 5 or 10% of that money as it arrives and give it to the cannabis compliance team so that it operates effectively and gets better and better as the months go by.

I will await your decision since the budget is now in process of being solidified and we will be looking at your response during the June 8 public hearing.

"The single Cannabis Compliance Team that is presently available can not simultaneously do both enforcement and licensing efficiently or effectively." This proposed expansion would create a cannabis compliance team comprised of 4 detectives, a supervisor and an administrative office professional. Dear Supervisors,

In 2019, when the cannabis tax was approved by voters, <u>you promised to 'use the majority of cannabis revenue to fund departments and agencies that oversee regulating and enforcing the cannabis industry.'</u> We are writing to request that you fulfill your promise by providing the necessary funding to adequately staff the Cannabis Compliance Team.

For the past three years, an underfunded and understaffed Cannabis Team, comprised of 1 Lead Detective, 5 Deputy Detectives and 1 Administrative Staff (civilian), have had the prime directive of enforcement for the cannabis industry in SBC. In addition to enforcement on all the growers, throughout the entire County of Santa Barbara, they have recently been assigned the duties of overseeing licensing (without additional funding or staff), which had previously been assigned to the Planning and Development Department. Furthermore, coming down the pipeline, there are multiple, huge cannabis projects that will put even more demands upon the Team.

In April 2021, at the BOS Budget Workshops, Santa Barbara County Sheriff, Chief Deputy Bonner stated, "The single, Cannabis Compliance Team that is presently available cannot simultaneously do both enforcement and licensing efficiently or effectively." It was also reported that there are at least 21 suspected, illegal growers and dozens of illegal delivery services operating in our county that the Team was unable to investigate and/or enforce on. Chief Deputy Bonner also stated, "...that of the 108 growers, 50 percent claimed no income or did not file at all."

When a sufficiently funded and staffed Team is able to enforce the required tagging of plants then, they will have the data, necessary to compute every growers' income. The tagging of plants provides the number of plants, which along with the going price of cannabis, at time of sale, will provide the income that the grower should report. By continuing to underfund the Team, SBC will never receive the revenue that these growers actually owe because you will never know what they are actually producing..., unless that is the intention. We strongly recommend that you provide the necessary funding for the Team to do the job you have asked them to do, which will ensure that growers are paying their full, fair share and therefore, provide the necessary funding to reimburse the county.

For the last three years, both law enforcement and communities throughout our county have asked you to fully fund our essential Cannabis Compliance Team and you have refused. If you refuse to adequately fund them for a *fourth year in a row*, then "We the People" demand to know *WHY* (emphasis added).

Dear County Supervisor,

I write to express my strong support to improve racial justice and prioritize humane treatment for justice-involved people in our County. I respectfully but firmly call on you to reallocate our criminal justice budget to advance transformational changes:

Permanently reduce Sheriff's Department funding to support a long term average jail population of approximately 550.

Reduce general funding for our Sheriff's Department by up to \$26.7 million and 165 FTEs to bring our Sheriff Department budget in line with comparable counties.

Reduce Sheriff's Department funding for traditional policing that doesn't reduce recidivism. Reallocate funds to community-based diversion and alternatives to jail, including more funds for the Behavioral Wellness Department to provide non-jail alternatives for mental health and addiction needs. Reallocate funds to support transition planning for jail residents returning to our community.

Increase funding for the Public Defender Department to expand holistic advocacy and culturally competent staff to improve advocacy across the racial/ethnic spectrum.

Reallocate funds to County CEO to expand and centralize data collection and analytics. Require Departments to provide evidence-based data for programs to reduce recidivism.

Offer a grant to the Sheriff's Department to expand jail internet and volunteer access -- including the award winning Freedom to Choose program that reduces recidivism.

Rethink plans for \$28M to refurbish the South County Jail. Reduce footprint to about 200 jail beds. Repurpose funds to build transitional housing to help stabilize eligible jail residents' re-entry into our community. Build a separate assessment center to screen and divert those who are appropriate for community-based alternatives.

Fund seed money to study a possible Civilian Oversight Commission to help assure Sheriff Department transparency and accountability, and deter police misconduct.

Transformational change requires courage. I will watch for you to vote for big change now. The commissioned KPMG studies and we, the people, will support you in this.

My home is located in an EDRN, where cannabis isn't allowed to be cultivated. However, many applicants are in the pipeline immediately adjacent to the EDRN. Some have been "busted" by the sheriff (Herbal Angels) for illegal activity. Some of these applicants are still in the pipeline despite their criminal activities, which were causing great concern to the residents all around the grow. Traffic in and out at all hours, strange cars and people, apparent drug deals right in plain sight. Only the Enforcement Team put a stop to it.

Now, new cannabis Permit applicants are coming before the board, also of dubious character. Hopefully, the BOS will not approve them, as these permits "run with the land"in perpetuity. That means forevermore, the residents will have to be vigilant and be wary. Without adequate enforcement, illegal activity and general noncompliance will be rampant, endangering public safety.

A moratorium on new permits should be issued until such time an adequate Cannibis Enforcement Team can be funded. Tax revenue from existing "grows", if such a good source of revenue for the County Tax Collector, should more than cover the expense.
