This is the first Amendment to the Agreement between THE COUNTY OF SANTA BARBARA (hereinafter "County") and Endelos Energy, Inc. (hereinafter "Contractor").

WHEREAS, on November 19, 2019, the parties hereto entered into an Agreement for Services of Independent Contractor BC19490 (hereinafter "Agreement") in connection with the Betteravia Renewable Energy System Project ("Project"); and

**WHEREAS,** the Agreement was initially for 18 months from the execution of the original contract, but no later than JUNE 30, 2021; and

**WHEREAS,** the parties hereto desire to amend the Agreement ("Amendment No. 1"), in accordance with the provisions of the Agreement, to extend the term and provide compensation for said additional services.

#### NOW, THEREFORE, Owner and Contractor agree as follows:

- 1. Amendment No. 1 increases the maximum compensation limit of \$4,336,751.00 by \$162,992.49 for a Maximum Compensation Limit (MCL) of \$4,499,743.49.
- 2. Amendment No. 1 increases the term of the contract and replaces the "TERM" clause with the following:
  - **TERM.** CONTRACTOR shall commence performance in accordance with scope of work and end performance within six months of the delivery to the COUNTY of the Caterpillar C15 500 Kw Stationary mounted generator set, or DECEMBER 31, 2021 whichever comes later, unless otherwise directed by COUNTY or unless earlier terminated.
- 3. Amendment No. 1 is effective starting June 15, 2021.
- 4. Exhibit B of the Agreement is hereby replaced with the revised attached Exhibit B, which specifies the revised MCL that the County will pay to the Contractor inclusive of all authorized Services and authorized Reimbursable expenses and revises the Milestones Project Payments table.
- 5. Except as otherwise amended by this Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect.

The signatories to this Amendment have the authority to bind the parties. This Amendment may be executed in counterparts, each of which shall be deemed to be an original, and all of such counterparts shall together constitute one executed original instrument.

## PAYMENT ARRANGEMENTS Periodic Compensation at Selected Milestones

- A. For CONTRACTOR services to be rendered under this contract, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed \$4,499,743.49. This agreement is contingent on funding and a Notice to Proceed by the Director of General Services or the County Representative. The COUNTY is not responsible for any payments or reimbursements prior to the Notice to Proceed. The COUNTY has the right to cancel this contract if no funding source is established.
- B. Payment for services and/or reimbursement of costs shall be made upon CONTRACTOR's satisfactory performance, based upon the scope and methodology contained in **EXHIBIT A** as determined by COUNTY.
- C. Upon completion of the work for each milestone and/or delivery to COUNTY of item(s) specified below, CONTRACTOR shall submit to the COUNTY DESIGNATED REPRESENTATIVE an invoice or certified claim on the County Treasury for the service performed in accomplishing each milestone. These invoices or certified claims must cite the assigned Board Contract Number BC19490. COUNTY REPRESENTATIVE shall evaluate the quality of the service performed and/or item(s) delivered and if found to be satisfactory shall initiate payment processing. COUNTY shall pay invoices or claims for satisfactory work within 30 days of presentation.
