Sixth Amendment
To the
Community Development Block Grant Agreement For
Cuyama Valley Recreation District Park Improvements

WHEREAS, the County of Santa Barbara (COUNTY) executed an Agreement (AGREEMENT) between the COUNTY and CUYAMA VALLEY RECREATION DISTRICT (OWNER), dated November 14, 2017, pursuant to the Community Development Block Grant program from the United States Department of Housing and Urban Development ("HUD") under Title I of the Housing and Community Development Act of 1974, as amended (HCD Act), Public Law 93-383 (42 U.S.C. §§ 5301 et seq.); and the regulations promulgated thereunder (24 CFR Part 570) ("Regulations"); and

Recitals

WHEREAS:

1. The COUNTY has received funds from the United States Department of Housing and Urban Development ("HUD") under the Community Development Block Grant program, hereafter referred to as CDBG, under Title I of the Housing and Community Development Act of 1974, as amended, for the purpose of supporting community development activities that benefit low- and moderate-income persons; and
2. On July 11, 2017 the County Board of Supervisors adopted and approved submittal to HUD of the Santa Barbara County CDBG Urban County 2017-2018 Action Plan which reserved CDBG funding in the amount of Three Hundred and Forty-One Thousand Hundred Dollars (\$341,000), for the Cuyama Valley Recreation District Park Improvements (PROJECT) located in New Cuyama, California; and
3. On November 14, 2017, the parties entered into an AGREEMENT to carry out the PROJECT; and
4. Section II describes the Term of the AGREEMENT as ending on September 30, 2018; and
5. On September 27, 2018, the parties entered into a First Amendment to extend the term of the AGREEMENT to March 30, 2019; and
6. On March 19, 2019, the parties entered into a Second Amendment to extend the term of the AGREEMENT to March 30, 2020;

7. On March 24, 2020, the parties entered into a Third Amendment to extend the term of the AGREEMENT to March 31, 2021, with provision which Term may be extended up to a maximum of 6 months until September 30, 2021 by the Director of the County Community Services Department, or designee, at his or her discretion;
8. On May 5, 2020, the parties entered into a Fourth Amendment to award additional funds in the amount of \$58,485 to the PROJECT, for a total allocation of \$399,485 in CDBG funds;
9. On March 29, 2021, the parties entered into a Fifth Amendment to extend the term of the AGREEMENT to September 30, 2021; and
10. Additional funding in the amount of \$100,000 is needed to complete the PROJECT; and
11. The PROJECT is not complete and additional time is needed to complete the Project;

NOW THEREFORE, it is mutually agreed by COUNTY and CUYAMA VALLEY RECREATION DISTRICT to increase the Project budget by \$100,000 and to extend the Term of the Agreement to June 30, 2022. As modified by this Sixth Amendment, the Project budget is increased to a total of \$499,485.

This Sixth Amendment may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original; and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.

Except as set forth hereof, this Amendment shall not modify or change any of the provisions of the Agreement and the parties to the Agreement are bound by its provisions, as amended herein.




