FIRST AMENDMENT TO MEASURE A PROJECT COOPERATIVE AGREEMENT

For project awarded to County of Santa Barbara in Cycle 4 of the Measure A Bicycle and Pedestrian and Safe Routes to School Programs

This First Amendment to the Cooperative Agreement ("First Amendment") is entered into by and between the County of Santa Barbara, a municipal corporation ("Sponsor") and the SANTA BARBARA COUNTY ASSOCIATION OF GOVERNMENTS, a State local government, acting as the Santa Barbara County Local Transportation Authority ("Authority").

WHEREAS, on June 20, 2019, Authority and Sponsor entered into a Cooperative Agreement to provide funding from the Measure A Cycle 4 South Coast Safe Routes to School, Bicycle and Pedestrian Program specified herein (the "Program") to Sponsor's projects for the particular transportation improvement project work specified in the Cooperative Agreement (the "Projects"); and

WHEREAS, Sponsor is requesting an amendment to change the implementing agency from COAST to Santa Barbara Bicycle Coalition (SBBIKE) for the Safe Routes to School project as shown in Attachment G of the Cooperative Agreement; and

WHEREAS, Authority may approve changes to the implementing agency in accordance with Sections 1.2 and 3.7 of the Cooperative Agreement;

WHEREAS, the Cooperative Agreement Section 3.7 Amendment requires both Parties agree to change or modify the Agreement in writing.

NOW, THEREFORE, in consideration of the mutual promises and undertakings herein made and the mutual benefits to be derived therefrom, the Parties hereby agree to amend the Cooperative Agreement through this Third Amendment as follows:

- Section 1.2.a is added in its entirety as follows:
 - 1.2.a. Sponsor requested, and Authority approves a change in the implementing agency from COAST to Santa Barbara Bicycle Coalition (SBBIKE) for the Safe Routes to School project.
- 2. Attachment G as attached hereto and incorporated herein by this reference is amended as follows:
