Beyond the Blueprint: June 15th

- > All sectors may return to usual operations without limits on capacity and physical distancing
- ➤ Color-coded tier system for counties has been retired
- ➤ Masking is still required in many situations and settings



Guidance for Face Coverings

- > Fully vaccinated individuals:
 - Masks are not required in most settings, except where required for All People
- Unvaccinated or Partially Vaccinated individuals:
 - Masks are required for unvaccinated individuals in indoor public settings and businesses
- ➤ No person can be prevented from wearing a mask as a condition of participation in an activity or entry
- > Businesses, venues, and hosts may choose to:
 - Use a self attestation compliance method to determine compliance
 - Implement vaccine verification
 - Require all patrons to wear a mask

Guidance for Face Coverings

- > All people: both fully vaccinated and unvaccinated people must wear masks in these settings:
 - Public transit (examples: airplanes, ships, ferries, trains, subways, buses, taxis, and ride-shares)
 - •Transportation hubs (examples: airport, bus terminal, marina, train station, seaport or other port, subway station, or any other area that provides transportation)
 - •Workplace: Masks must continue to be worn on the job. Cal/OSHA will be reviewing its masking guidance for employers and workers on June 17th
 - •Indoor K-12 schools, childcare facilities, and other youth settings
 - •Healthcare settings (including long-term care facilities)
 - •Homeless shelters, emergency shelters, and cooling centers
 - Correctional facilities and detention centers
 - Businesses that choose to require masks for all customers



Guidance for Business, Boards, Commissions

- In settings where masks are required only for unvaccinated individuals, businesses, venue operators, or hosts may choose to:
 - Provide information to all customers, guests and attendees regarding vaccination requirements and allow vaccinated individuals to self-attest that they are in compliance prior to entry.
 - Require proof of vaccination.
 - Require all patrons to wear masks.
- Businesses may deem a customer, guest or attendee to have self-attested to being vaccinated, or to have met an approved masking exemptions, if the business has prominently displayed signage prior to entry explaining the requirements for unvaccinated individuals to wear a mask and the individual enters the business premises without wearing a mask.

Mega Events

- ➤ Mega Events are large crowds >=5,000 people indoors and >=10,000 people outdoors.
- > These events are considered higher risk for COVID transmission due to:
 - Spending extensive periods of time physically close to a large number of people, thereby increasing the risk that respiratory particles will be transmitted
 - Attendees usually include participants from multiple states and countries who may be infected with more infectious COVID variants
 - Effective contract tracing is difficult due to the nature of these events



Mega Events

- Indoor events (conventions, conferences/expos, sporting events, and concerts)
 - Requires verification of fully vaccinated status or a pre-entry negative test for all attendees
 - Face coverings are required regardless of vaccination status
- Outdoor events (music or food festivals, car shows, parades, sporting events, concerts)
 - Verification of fully vaccinated status or a pre-entry negative test for all attendees is strongly recommended
 - Face coverings are required regardless of vaccination status. Venues are required to have masks available for all attendees
- Effective June 15, 2021 through October 1, 2021



Vaccination Efforts



Benefits of Being Fully Vaccinated

Fully vaccinated individuals can:

- Spend time with other fully vaccinated people without wearing masks or physical distancing, including indoors
- Spend time with unvaccinated people from a single household who are at low risk for severe COVID disease without masks or physical distancing
- >Are not required to wear masks outdoors and indoors in most settings
- > Travel safely within the United States and California
- >Are not required to quarantine and testing following a known exposure if asymptomatic
 - Testing is still recommended if an individual is experiencing COVID-19 symptoms

% of SB County Vaccinated


(first or single dose)
