The County of Santa Barbara's County Executive Office (CEO) intends to send a letter to the State Licensing Authority within 30 calendar days of date of this letter to notify the State, in accordance with Business and Professions Code section 26055, that your cannabis operation does not comply with local laws and/or regulations.

ecifically, it has come to the CEO's attention that your cannabis operation:
No longer has a land use application pending with the Santa Barbara County Planning and Development Department, as required to maintain legal nonconforming use status, and has not obtained a land entitlement
Failed to file the required quarterly tax reports for two or more consecutive quarters as reported by the County Office of Treasurer-Tax Collector
Failed to make appropriate progress through the Land Use Permitting Process as required by the Planning and Development Department
☐ Land use application or business license application has been rejected or denied
Subject of a law enforcement investigation resulting in evidence suggesting violation of criminal or administrative statutes
Subject of repeated neighborhood complaints describing actions detrimental to the quality of life in the surrounding neighborhood (e.g. odor complaints focused on a specific property)

If you disagree with this determination, you are entitled to schedule a meeting with County Staff within 10 calendar days from the date listed in this letter. At that meeting, you are welcome to offer explanations and/or evidence that would mitigate the concerns raised in this letter.

Should that meeting fail to resolve the issues in question, you will have the opportunity to request a hearing by submitting a written request at the County Executive Office at: 105 E. Anapamu Street, Room 406, Santa Barbara, CA 93101. The CEO's office will schedule a hearing with a neutral hearing officer. All decisions of the Hearing Officer are considered final. Enclosed is a copy of the County's State Licensing Contact Protocol that is also posted on the County's cannabis website at: http://cannabis.countyofsb.org.

You are not required to meet with the County Staff nor are you required to have a hearing. However, you are entitled to both steps in that process to ensure that your position is fully explained prior to a final decision to submit a notice of withdrawal to the State.
