#### **Recommended Actions:**

- a) Authorize the Chair to execute agreements for specialized crane services for the period of July 1, 2021 through June 30, 2023, in the amount of not to exceed \$1,000,000 with each of the following contractors:
  - i) Bragg Crane Service (a local vendor)
  - ii) T & T Trucking & Crane Service (a tri-county vendor)
  - iii) OST Crane Service Inc. (a tri-county vendor)
- b) Authorize the Chair to execute agreements for trucking services for the period of July 1, 2021 through June 30, 2023, in the amount of not to exceed \$1,000,000 with each of the following contractors:
  - i) Bob's Backhoe & Trucking (a local vendor)
  - ii) RLF Trucking & Grading Corp (a local vendor)
  - iii) Rockin CJ Transport Inc. (a local vendor)
- c) Find that the recommended actions to award contracts for crane and trucking services are fiscal activities not constituting a "Project" within the meaning of the California Environmental Quality Act, as set forth in 14 CCR 15378(b)(4).

#### **Summary Text:**

This item is on the agenda in order to approve the specialized crane and trucking service agreements. On April 1, 2021, the Flood Control District sent out Notice to Bidders (NTBs) to 25 trucking and crane companies and four plan rooms in the tri-county area. The Request for Proposals (RFPs) were posted on PlanetBid and the NTBs were published in the Santa Barbara Newspress and the Santa Maria Times on April 1, 2021.

On May 3, 2021, five trucking proposals and three crane proposals were received. After reviewing the proposals, the above-identified contractors were selected based on cost, geographic location, and type of equipment available. Selecting contractors that are geographically diverse throughout the County and outside of the County saves money, time, and the ability for contractors to respond during flooding in the event that the north or south HWY 101 closes.

These agreements will provide trucking and crane services needed to assist the Flood Control District with our routine maintenance program as well as assist in emergency response efforts. All work will be provided at an hourly rate and on an as-needed basis.

After the initial emergency period, eligibility to apply for state and federal funding reimbursement requires contracts go through a competitive bidding process. In the past, this process has allowed the Flood Control District to receive reimbursement for these costs from state and federal agencies for emergency response efforts.

#### **Background:**

In addition to reaching out to local companies for these services, an outreach was also conducted for Minority Business Enterprises and Women Business Enterprises (MBE/WBE) in the tri-county area. We conducted a targeted search on the Caltrans website and the Small Business Administration database for companies that provide crane and trucking services located throughout the tri-county area. NTBs were emailed to all of the identified companies. Ads were also published online specifically seeking MBE/WBE in the Compliance News Publishing Company, DBE GoodFaith, and Construction Bid Source. MBE/WBE outreach is required during the procurement process for contracts to be eligible for federal funding after the exigent period of a disaster.

In general, these contracts do not approach the not-to-exceed limits of the contract. The limits are set at a high dollar amount in preparation for response to flood and fire events that may occur in any given year. If we do start to approach the contract limits, the District would, if needed, return to the Board to approve a Budget Revision Request to release designations and increase the contract amounts.
