Subject: Goleta Beach Long-term Protection Plan

### **Background**

I am Professor of Environmental Studies and Earth Science at UC Santa Barbara where I been employed since 1976. I served as Chair of the Environmental Studies program for seven years. My research efforts with my graduate students are divided into three areas: 1) studies of Quaternary stratigraphy and tectonics as they relate to earthquake hazard active folding and mountain building processes; 2) study of river process, and fish habitat in the chaparral environment in southern California; and 3) studies of coastal processes of coastal lagoons in the Santa Barbara area. I am knowledgeable of the coastal processes, which shape beaches. I have taught a course in beach processes for years and have written several books that discuss coastal processes. I am qualified to speak as an expert regarding coastal erosion and sediment transport processes.

#### Statement

I support the new Goleta Beach 2.0 concept because it is the right project at the right time. It is more consistent with my past views of how to manage beaches than prior proposals to protect Goleta Beach County Park. Analysis done for prior proposals were flawed and failed to account for a variety of conditions at Goleta Beach. The dominant wave energy comes from the northwest and periodically produces large waves from storms, particularly during El Nino years. Development of the new Goleta Beach 2.0 plan initially in 2008 by Philip Williams and Associates as the Park Reconfiguration Alternative is based on the best available science. The strong point is that it anticipates variable ocean, coastal and storm conditions, including El Nino events.

The new approach to protecting Goleta Beach Park impact is based on Dr. David Revell's paper (referenced in the Beach Stabilization Project 2006 draft EIR), which identifies the flow of sand at Goleta Beach, which varies over several decades with cycle of the Pacific Decadal Oscillation and El Nino events. The historical record demonstrated by Revell shows the cyclical nature of beach widening and narrowing related to the sand supply and transport. Goleta Beach may be is entering a natural widening. In future years is may narrow again but these natural changes can be planned for. Rock revetments, groins and other hard structures are know to interfere with sand movement and sea walls (rock revetments) over decades can and often do reduce beach width. What is sure to happen with a rock revetment is that they will limit access to the beach. A rock is difficult to climb down, is unsightly and is not appropriate for a beach park that is visited by people who wish a beach experience.

### **Protect Utility Lines and Parking by Moving Them**

Goleta Beach 2.0 will maintain a more natural beach, allowing beach processes change with time The movement of utilities, restrooms and parking lots away from expected

coastal erosion that might occur over a period of decades is an example of proactive beach management, and I would move them as far back as possible.

### **Future Actions: East End of Park**

The east portion of the park is an area of particular public concern. I believe he eastern end parking lot should be removed and returned to a more natural landscape allowing the mouth of the slough to naturally migrate with the flow of sand along the beach. It will migrate mostly to the east toward More Mesa as that is the dominant direction of sand flow along the coast. The slough mouth is the most scenic part of Goleta Beach Park, but now it is spoiled by a parking lot protected by revetments. The parking lot and revetments, built to protect the parking lot degrades Goleta Slough. In my opinion, the eastern end of the sand spit, the slough mouth and lower slough should be a natural environment where people could learn about observe coastal and wetland processes. A non-intrusive visitors center could be located there where children and others could learn about our coastal resources. It could be an attraction rather than the scenic distraction it is today.

Parking spaces would be further reduced, but alternatives are possible. It has been my observation that a parking shortage only occurs the days when the beach is heavily used. During those days I believe there should be some additional parking away from the beach perhaps, out of the park with a shuttle service. It is poor management to place parking lots in scenic areas of high public value. People at other Southern California beaches park their cars then walk to the beaches, and it seems to be working. The County's plan includes a drop off place for people to let people off and then provide parking, closer perhaps to the airport. This is a sound approach to managing Goleta Beach.

I object to construction of a hidden "backstop" rock revetment or sea wall approximately 50 feet back from the beach. In my estimation this is not an appropriate expenditure of money. If we implement Goleta Beach 2.0 we will observe over a period of years that there will be periodic erosion and deposition on the beach. During some years the erosion may appear unacceptable—that is the time to remember the long-term goal of maintaining the beach. Periodic beach nourishment following storm and beach erosion is by far less costly than a rock revetment that will require expensive maintenance. The study by Revel and Griggs (2005) published in Shore and Beach is correct then periodically Goleta Beach will receive a pulse of sediment that will lead to natural widening of the beach. Other times the beach will experience erosion and narrow. Spending large amounts of money for a hidden (buried) sea wall doesn't make much sense to me. As sea levels rises (and it will by perhaps a foot or so this century, the beach will migrate inland). What we need to do now is anticipate change over say 50 to 100 years and at least make a value judgment of what we would like Goleta Beach to be like in the more distant future. Some day there may be a raised bridge across the entire area from sea cliff to sea cliff across the entire inlet. The beach in 2100 may even be landward of Highway 217, but there will be a beach; that is unless we choose to destroy Goleta Beach by trying to save it. The sand spit we call Goleta Beach, even as it has been modified over many decades by fill and development, is one of the few dynamic places along our coast where change is normal and necessary. We have a responsibility to future generations to insure places such as Goleta Beach are part of their future.

### **Summary**

I favor Goleta Beach 2.0 over previous suggested projects, but not including a backstop rock revetment at the west end and not including the eastern revetment. Maintaining these revetments will add significant expense of the project and should large waves attack the beach they probably would erode past the rock revetment (buried or not) as other sea walls have. Furthermore it seems to be a waste of money to plan to excavate a large area and bury a sea wall under Goleta Beach 2.0. Once a seawall is placed it is almost never removed, but commonly is replaced over a period of years by bigger, more expensive seawalls. Seawalls never are constructed to save a beach. They are built to protect coastal development. Sometimes that is critical, but not for a beach park with high scenic value.

In closing, I endorse Goleta Beach 2.0 but without the backstop revetment. Please direct your staff to pursue Goleta Beach 2.0 less the backstop revetment. Please direct staff to recommend that utility lines be moved as far inland as possible. This will ensure that Goleta Beach 2.0 is a long-term cost effective solution for Goleta Beach Park.

Goleta Beach 2.0 is a new approach to preserving and enhancing Goleta Beach Park. The Coastal Commission voted 9-1 to deny the permeable pile groin last year over concerns that proposal would cause beaches to narrow and bluffs to erode more rapidly. A new approach is needed and Goleta Beach 2.0 is just that. The County Parks Department staff should be thanked for developing such a progressive, scientifically-strong plan to protect our Goleta Beach Park while also protecting the beach. The County's prior plan for Goleta Beach - the permeable groin - would have shifted the erosion to other areas like More Mesa. It would have fought nature and cost millions of dollars. In the end it would have damaged our beaches. The Coastal Commission denied the groin project for that reason. Goleta Beach 2.0 works with nature. It increases the size of Goleta Beach by an acre.
