## SECOND AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

THIS SECOND AMENDMENT to the Agreement for Services of Independent Contractor (hereafter the "Second Amendment"), is made and entered into this 13<sup>th</sup> day of July 2021, by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter "County") and Satellite Tracking of People, LLC., (STOP) (hereafter "Contractor"). For purposes of this Second Amendment, the County and Contractor shall be referred to collectively as the "Parties."

WHEREAS, the Parties entered into an Agreement for Services of Independent Contractor on August 23, 2016 with an effective date of September 1, 2016 (hereafter the "Agreement"), by which Contractor agreed to provide GPS monitoring services to Sheriff's Office Alternative Sentencing Unit; and

WHEREAS, the Agreement provides that the term of the Agreement shall commence on September 1, 2016, and ended on August 31, 2020;

WHEREAS, a First Amendment was executed extending the term to August 31, 2021;

WHEREAS, the Parties desire to extent the Agreement for one additional year.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, it is mutually agreed upon as follows:

- 1. The term of the Agreement is now extended to August 31, 2022.
- 2. In all other respects, the terms and conditions of the Agreement shall continue unchanged and in full force.
