On July 13, 2021, set a hearing for August 31, 2021, to consider Case No. 21APL-00000-00027, an appeal of the Planning Commission's May 5, 2021, approval of the Canna Rios, LLC Cannabis Cultivation Project (Case No. 19LUP-00000-00116). The appeal was filed by Courtney Taylor on behalf of Bien Nacido Vineyards, et al.
