 - 3) Hot Springs Road Shoulder Improvements; County Project No. 820764; First Supervisorial District;
 - 4) Obern Trail Pavement Rehabilitation; County Project No. 820728; Second Supervisorial District.

Summary Text:

This item is on the agenda to approve the 2020 Isla Vista Pasado Road Sidewalk Infill; East Mountain Drive Bridge No. 51C-0396; Hot Springs Road Shoulder Improvements; and Obern Trail Pavement Rehabilitation construction projects as constructed, and approve the attached Statements of Final Ouantities.

Background:

Isla Vista Pasado Road

This project constructed a continuous pedestrian path on the south side of Pasado Road from Camino Corto to Camino Pescadero, for an approximate length of 2,280 feet. These locations completed key links in the sidewalk network and improved pedestrian route connectivity in the Isla Vista area.



East Mountain Drive Bridge No. 51C-0396

This project reconstructed a bridge destroyed during the 1/9 Debris Flow. This bridge is primarily used as a bicycle and pedestrian access to adjacent trails and public recreational easements. The bridge will be closed to vehicular traffic except during emergencies, when first responders will have access and may allow for public use during evacuations.



Hot Springs Road Shoulder Improvements

This project reconstructed the shoulder of Hot Springs Road from the Santa Barbara City Limits to Middle Road in conformance with the Montecito Community Plan by creating an informal pathway on

the south shoulder. The pavement on Hot Springs Road was rehabilitated to repair damage from trucking and other construction traffic during 1/9 Debris Flow response and subsequent recovery. This path creates a vital pedestrian link in the trail network throughout Montecito and creates an area for pedestrians to avoid walking in the bike lane.



Obern Trail Pavement Rehabilitation

Construction of this project completed the rehabilitation of a 1.7-miles stretch of Obern trail from Golf Course Bridge to Maria Ygnacio Creek Bridge.
