

**Resolution of the Board of Supervisors of the County of Santa Barbara, State of California**

IN THE MATTER OF APPROVING AN AGREEMENT )  
WITH THE CALIFORNIA OFFICE OF EMERGENCY ) RESOLUTION NO: 21-132  
SERVICES FOR THE ELECTRONIC SUSPECTED CHILD )  
ABUSE REPORTING SYSTEM (E-SCARS) PROGRAM )

WHEREAS, the County of Santa Barbara District Attorney desires to continue a certain project designated as the Electronic Suspected Child Abuse Reporting System (E-SCARS) Program, to be funded in part from funds made available through the Governor’s Office of Emergency Services (Cal OES).

WHEREAS, the District Attorney was awarded grant funding from Cal OES for the E-SCARS Program, subject to Board approval, in the amount of \$250,000, for the grant period of January 1, 2021 through December 31, 2021.

NOW, THEREFORE, BE IT RESOLVED that the District Attorney of the County of Santa Barbara is authorized to submit the Application for the Electronic Suspected Child Abuse Reporting System (E-SCARS) Program to Cal OES and to accept and sign on behalf of the County of Santa Barbara the attached Grant Subaward for the E-SCARS Program, for the period of January 1, 2021 through December 31, 2021 in the amount of \$250,000, including any amendments to the Grant Agreement extending the term thereof through June 30, 2022, or for a supplemental grant award in the amount not to exceed \$50,000.

BE IT FURTHER RESOLVED that the applicant agrees to provide any matching funds required for said project (including any extension or amendment thereof) and the rules and regulations of Cal OES.

BE IT FURTHER RESOVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
