Recommended Actions:

That the Board of Supervisors:

- A. Set a public hearing for August 10, 2010, (30 minutes total; 15 minutes staff) to consider the introduction (first reading) of an Ordinance (Attachment 1) adding Section 23-13.11 to Chapter 23 of the Code of Santa Barbara County, prohibiting the use of a portion of Harris Grade Road by certain vehicles in the Lompoc area.
- B. Set a public hearing for September 7, 2010, on the Administrative Agenda to consider the adoption (second reading) of an Ordinance adding Section 23-13.11 to Chapter 23 of the Code of Santa Barbara County, prohibiting the use of a portion of Harris Grade Road by certain vehicles in the Lompoc area.
- C. Approve the filing of a Notice of Exemption pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15301 (c), pertaining to maintenance and operation of existing facilities, for this project.

Summary Text:

Harris Grade Road is a two-lane road that runs north and south between State Route 1, north of Lompoc and State Route 135, south of Orcutt. The 4 northern-most miles of Harris Grade Road, south of State Route 135, have many sharp curves. Signs are posted to inform drivers that semi-trailers are not advised.

In 2008, the Public Works Department received a request to restrict trucks from using the northern 4 miles of Harris Grade Road. The Department investigated the road and determined that most advisory

conditions were adequate and no restrictions were needed, but that advisory signage at the south end needed modification. At that time the Department relocated the existing sign and added new signs.

In October 2009, the California Highway Patrol (CHP) requested that the County restrict semi-trailers on Harris Grade Road because of an increase in call-outs on the road involving semi-trailers. Accident data also show a significant increase in collisions involving semi-trailers in the last year. From 2000 through 2008, there were 4 collisions involving semi-trailers; there were 4 in 2009 alone. Based on this collision history, the Department determined that the sharp curves on Harris Grade Road are a safety concern, and a length restriction should be imposed. The Department recommends prohibiting semi-trucks, and vehicles with trailers over thirty feet in total length, from using Harris Grade Road between Burton Mesa Boulevard and State Route 135.

Once posted, this restriction will upgrade the "semi-trailers not advised" condition on Harris Grade Road to a regulatory condition enforceable by the CHP. Violators will be subject to a fine of \$100.00.

Background:

The Section 21101(c) of the California Vehicle Code (CVC) allows local authorities, by Ordinance or Resolution, to adopt rules and regulations prohibiting the use of particular highways by certain vehicles.
