Re: Utility-Scale Solar

Honorable Chair Nelson and Members of the Board,

Thank you for providing an opportunity to weigh in on this item. Generally speaking, I am a proponent of developing alternative, green energy sources but I am opposed to having large-scale industry, of any kind, developed in our remote, inland communities. I support homeowners' development of solar systems for personal use, on private lands and putting solar systems on buildings, parking lots, etc., in appropriate regions.

I guess the bottom line for me is this. I do not want to see our beautiful, scenic lands covered in hundreds of acres of glaringly reflective solar panels, any more than I want to see hundreds of acres of obtrusive hoop structures on these once, pristine lands.

Upon review of Board documents, I have the following concerns:

- 1. Allowing commercial-scale industry of any type, including solar industry, in Tepusquet Canyon and other small, rural unincorporated communities, presents risks that are similar to allowing commercial cannabis industry. Tepusquet Canyon is inappropriate for this type of use because we too, are "...characterized by steep slopes and areas with outstanding resource values, including environmentally sensitive habitats and/or watersheds... and unsuited for intensive development."
- 2. Tepusquet Canyon Road is narrow, winding and mostly undivided. It has many blind, hairpin turns and is deemed substandard. Increased levels of commercial vehicles and employee traffic pose a risk to our community. An expansion of use to our road would add to the level of heavy, commercial industry traffic.
- 3. Commercial industry will have heavy, negative impacts on flora and fauna, especially in the remote regions of our County.
- 4. Re Environmental Review: I am confused about the interpretation of CEQA Guidelines. I understand that developing the ordinances may not be subject to CEQA but the proposed Utility-Scale Solar Projects will, most certainly, "result in direct or indirect physical changes in the environment." When will CEQA become involved? After projects come before the PC/BOS?
- 5. Re Fiscal and Facilities Impacts: I strongly disapprove of using P&D's Long Range Planning Division Budget (\$200,000), Cannabis tax revenue (\$171,000) and Planning and Development Budget funds (\$29,000) for consultant services. This amounts to \$400,000 for consulting costs, alone!!! This use/abuse of taxpayer funds infuriates me because the BOS has refused to fulfill their promise to protect public health and safety, by funding an additional, Sheriffs Cannabis Compliance Team, for FOUR YEARS!!! How can you justify spending that amount of money on *consultant services*, when you won't protect countywide residents, from illicit cannabis industry?!?
