



Pursuant to GC 27388, recording fees are collected in filing of certain real estate instruments, papers, or notices and are for the exclusive use of the District Attorney in order to deter, investigate, and prosecute real estate fraud crimes. Total expenditures for the Real Estate Fraud program are estimated at \$430,657 and estimated recording fees total \$740,889. We estimate receiving \$310,300 in excess of expenses used to support current Real Estate Fraud prosecution efforts, therefore these excess funds need to be restricted to support Real Estate Fraud prosecution efforts.
