Summary Text:

The Board of Trustees of the Vista Del Mar Union School District adopted its Conflict of Interest Code amendments on April 15, 2021. Amendments to the Vista Del Mar Union School District's Conflict of Interest Code are required to add new positions that must be designated and revised based on updates to disclosure categories. (See Attachment A—2020 Local Agency Biennial Notice; Attachment B—April 15, 2021 Minutes of the Board of Trustees; Attachment C—Conflict of Interest Code, Redline Copy; Attachment D—Conflict of Interest Code, Clean Copy.)

Vista Del Mar Union School District Conflict of Interest Code Amendments Page 2 of 2

Background:

The Political Reform Act of 1974 requires every local government agency to:

- 1. Adopt a Conflict of Interest Code identifying the reporting requirements of covered employees,
- 2. Review the need for any changes to its code biennially, and
- 3. Submit an amended code to the "code reviewing body" if necessitated by changed circumstances. (Gov. Code, §§ 87300; 87302; 87306.5, subd. (a).)

The Board of Supervisors is designated as the code reviewing body for independent districts and agencies with jurisdiction wholly within the County. (Gov. Code, § 82011, subd. (b).) Once approved by your Board, the Vista Del Mar Union School District's proposed amended Conflict of Interest Code is deemed effective. (Gov. Code, § 87303.)
