SUBJECT: Update on the Coronavirus Disease 2019 (COVID-19)

Recommended Actions:

It is recommended that the Board of Supervisors:

- a) Receive and file a brief update on the Coronavirus Disease 2019 (COVID-19) and Santa Barbara County's response and operations;
- b) Provide any direction, as appropriate; and
- c) Determine that the above actions are not a project under the California Environmental Quality Act (CEQA), because pursuant to sections 15378(b)(4) and 15378(b)(5) the recommended actions consist of organizational, administrative or fiscal activities of government that will not result in direct or indirect physical changes in the environment.

Summary

Staff will provide the most recent information on the status of COVID-19 at the Board of Supervisors' meeting. On June 15, California moved into "Beyond the Blueprint" on June 15 and the colored tier system was lifted. Santa Barbara County buildings reopened to the public on June 16. After Cal/OSHA approved their revised Emergency Temporary Standards on June 17, 2021, lifting the physical distancing

requirement, the Board of Supervisor's resumed for in- person public participation with normal capacity on Tuesday, July 13, 2021 with an option for virtual participation via Zoom.

On July 26, 2021, as the Delta COVID variant numbers continued to climb in California, a State Health Order on masking and testing was announced for mandatory masking and testing in particular settings including acute health care, long- term care, high- risk congregate settings, and certain other health care settings. On August 4, 2021, the Santa Barbara County Public Health Department (SBCPHD) issued a local <u>Health Officer Order</u> mandating the use of universal face coverings in indoor settings countywide. The mandate went into effect on Friday, August 6, at 5:00 P.M. The County Health Officer will consider changes to the mandate when case rates, hospitalizations and ICU capacity decline in Santa Barbara County. SBCPHD is closely monitoring data on a regular basis which will determine the duration of the mandate. Circumstances and vaccination updates are changing daily with the most updated information on the Public Health information portal at <u>https://publichealthsbc.org.</u>

Discussion

Since March 2020, County Public Health has consistently informed the Board of Supervisors and the community at large about the status of the disease of communities, demographics of those impacted, status of health officer orders, status of schools and waivers, state monitoring metrics, hospital beds and ICU capacity, vaccine planning and distribution, guidance and updates from the California Department of Public Health, RISE Guide changes, business industry activity and outreach efforts.

Timeline of Santa Barbara County Movement through the tiers:

- September 29, 2020: Tier 2 Substantial/Red
- November 16, 2020: SBC reverted to Tier 1 Widespread/ Purple
- December 6, 2020: The County as part of the Southern California Region fell below 15% ICU capacity which triggered the Regional Stay at Home Order, which ended on January 25, 2021.
- January 26, 2021: Tier 1 Widespread/ Purple
- March 16, 2021: Tier 2 Substantial/ Red
- April 21, 2021: Tier 3 Moderate/ Orange
- June 8, 2021: Tier 4 Minimal/ Yellow
- June 15, 2021: Beyond the Blueprint

COVID-19 vaccination is one of the most important tools to end the COVID-19 pandemic. The State is prioritizing vaccines for equitable distribution to everyone in California who wants it. Current information on the County's vaccination plan is available on the County's website at publichealthsbc.org. As of August 9, 2021, 62.6% of eligible individuals in Santa Barbara County have been fully vaccinated, and 53% of all individuals in the county have been fully vaccinated. Daily case rate of unvaccinated versus vaccinated in Santa Barbara County is available on the <u>Public Health Community dashboard</u>.

Background

Emergency Proclamations and Health Orders. Since March 4, 2020, there has been a number of emergency proclamations and health orders related to the novel coronavirus (COVID-19). These can be found at: <u>https://publichealthsbc.org/health-officer-orders/</u>

On May 21, 2021, California announced the details of the state's full reopening plan "Beyond the Blueprint.". When California fully reopened the economy on June 15, 2021, the State moved into the

"Beyond the Blueprint". Beginning June 15, 2021, businesses returned to usual operations with limited exceptions for mega events. The updated framework clarifies that physical distancing and capacity limitations will no longer be required for most businesses. Employers are still subject to the Cal/OSHA COVID-19 Prevention Emergency Temporary Standard (ETS). Cal/OSHA Standards Board approved their updated ETS regulations on June 17, 2021. Following the June 17 vote by the Occupational Safety and Health Standards Board to adopt the revised COVID-19 Prevention ETS, Governor Gavin Newsom signed an executive order to allow the revisions to immediately take effect on June 17 including changes to face coverings and physical distancing requirements.

Following the State of California's Health Officer Order on facial coverings and testing in particular settings, SBCPHD issued a <u>Health Officer Order</u> mandating facial coverings in indoor settings countywide. This mandate became effective at 5:00 P.M. on August 6, 2021.

County's response and objectives. The County developed a list of objectives in response to the public health emergency. The list of objectives can be found in <u>Board Letter</u> from May 4, 2021.

Local vaccine distribution updates are available on the Public Health website at Vaccines. https://publichealthsbc.org/vaccine/. The Santa Barbara County Health Department will continue to follow guidelines from the California Department of Public Health (CDPH) and the Advisory Committee on Immunization Practices (ACIP) to prioritize vaccine distribution. Additional information on the vaccine distribution plan can be found at publichealthsbc.org. Santa Barbara County opened vaccine eligibility to all residents ages 12 year of age and older. Minors are only eligible for the Pfizer vaccine. Santa Barbara County currently has community vaccination clinics where all Californians ages 12+ may be vaccinated. Santa Barbara County vaccination clinics are now accepting walk-ins for all who wish to receive the vaccine. Mobile vaccination clinic information can be found at: https://publichealthsbc.org/vaccine/.

Emergency Operations Center. The response effort is coordinated through the Public Health Department's Department Operations Center (DOC), with support from the County's Emergency Operations Center (EOC) focused on mitigating the spread of COVID-19, reducing the potential overload to the health care system and reopening the community in a safe manner. The EOC closed the call center operations on May 28, 2021 as a result of a significant decrease in call volume. While the COVID Code Compliance Task Force has not been reactivated, SBCPHD has reinstated the COVID-19 Complaint form with the issuance of the facial covering HOO. The complaint form can be found <u>here</u>. The enforcement approach continues to be through education. Additional information on the EOC, including education and compliance, can be found in <u>Board Letter</u> from May 4, 2021.

County Department Operations. Where in-person services had been suspended, County departments began resuming in-person, in-office contact, with some departments opting to continue by-appointment, virtual and other arrangements depending on their services and customers/clients. The County is encouraging a hybrid approach with workplace flexibility to the degree feasible and depending on their populations served, Departments have been instructed to follow health safety protocols for COVID-19 for any employees on-site and have reopening plans in place for "Beyond the Blueprint". County buildings reopened to the public on June 16. The Board of Supervisors meetings reopened to the public on July 13, 2021 for in person public participation. As of August 6, 2021, per SBCPHD HOO, facial coverings are required in all indoor County buildings and facilities.

RISE Business Activity. The County published the Santa Barbara County Reopening in Safe Environment, or RISE Guide, on May 15, 2020 within the framework of the Blueprint for a Safer

Economy. With the move to Beyond the Blueprint, on June 15, the RISE program ended. The County will continue to update the recoverysbc.org site with resources for local businesses.

Response Costs and Funding.

On March 6, 2021, the federal government approved an additional stimulus package for COVID19 relief entitled the American Rescue Plan Act. Included in the \$1.9 trillion package was \$350 billion in direct funding to states, territories, tribes, counties and municipalities, \$10 billion for coronavirus capital projects, and \$1.5 billion over two years for revenue sharing counties. Santa Barbara County's direct allocation was approximately \$86.6 million. In addition to direct funding to local governments, the American Rescue Plan Act increased funding for various programs available for small businesses, created several new programs to aid small business, and provided various funding avenues for residents. County staff plans to bring ARPA funding recommendations to the Board in October 2021.
