<b>BE IT FURTHER RESOLVED</b> that The Clerk of the Board is directed to file with the County auditor-Controller, on or before August 31, 2021 a certified copy of this Resolution and the report, indicating doption by the Board. Upon such filing, the County Auditor-Controller shall enter the charges on the tax oll for the 2021-2022 fiscal year. The charges shall be collected at the same time and in the same manner, and subject to the same penalties and priority of lien as, County taxes are collected, and all laws providing or the collection and enforcement of County taxes shall apply to the collection and enforcement of the marges.
