Fee Ordinance Overview

- In line with County's fee policy of full cost recovery for department services provided to public.
- Necessary to offset costs to provide services to agricultural and commercial businesses.
- Recommend a 3-year phase in period for most fees, to minimize impact to local industry.
- Maintain high level of customer service to industry without increasing County subsidy.
- Contracted MGT of America, Inc., consulting firm with expertise in local government fee analysis.
- Analysis & Proposed fees reviewed by Auditor's-Controller Office.



Recommended Actions

- Set a hearing to the Administrative Agenda of September 21, 2021, to consider the following recommendations:
 - Consider and approve the adoption (second reading) of "An Ordinance Amending the Ordinance No. 4832, The Agricultural Commissioner's Fee Schedule.
 - Find that the proposed actions are administrative activities of the County, which will not result in direct or indirect physical changes in the environment, as they are fees necessary to cover operating expenses, and are therefore not a "project" as defined for the purposes of the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines sections 15273(a)(1), 15378(b)(55) and Public Resources Code Section 21080(b)(8)(A) and (B).
