## FIRST AMENDMENT

**WHEREAS**, this First Amendment incorporates the terms and conditions set forth in the Agreement, approved by the County of Santa Barbara on July 14, 2020.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the the parties agree as follows:

a. The Agreement is amended as follows:

## 1. Amendment

**EXHIBIT B: SERVICE COST** 

Medical Office Assistant (MOA) Hourly Fee. County shall pay HS an hourly rate of \$37.13 per hour to staff the Santa Maria Clinic with a Medical Office Assistant for an estimated 40 hours per week. This fee will automatically increase by 3% annually.

- 2. <u>Counterparts.</u> This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
- 3. <u>Effectiveness of Agreement</u>. Any and all other terms and provisions of the Agreement, as amended, remain in full force and effect.
