# FOURTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL LEGAL SERVICES

This Fourth Amendment to the Agreement for Professional Legal Services (AGREEMENT) between the County of Santa Barbara ("COUNTY") and Andrues/ Podberesky ("CONTRACTOR"), wherein CONTRACTOR agrees to provide and COUNTY agrees to accept the services specified herein.

WHEREAS, COUNTY continues to require the services of legal counsel to assist in providing legal advice and representation in the specialized area of False Claims Act litigation; and

WHEREAS, under Section 25203 of the California Government Code, COUNTY's Board of Supervisors may employ counsel to assist in the conduct of litigation in which COUNTY is a party; and

WHEREAS, Paragraph 26 of the AGREEMENT states the AGREEMENT may be altered, amended or modified by an instrument in writing, executed by the Parties; and

WHEREAS, the AGREEMENT was previously amended on October 15, 2019, December 20, 2020, and May 18, 2021; and

WHEREAS, COUNTY wishes to increase the maximum contract amount by Six Hundred and Fifty Thousand Dollars (\$650,000).

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

The Parties agree to amend the AGREEMENT as follows:

Exhibit B, Paragraph A is revised to state:

For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed One Million, Nine Hundred and Fifty Thousand Dollars (\$1,950,000).

In all other respects, the AGREEMENT remains unchanged and in full effect.
