#### Summary

Case No. 21APL-00000-00027, the Bien Nacido Vineyards, et al. appeal of the Canna Rios, LLC Cannabis Cultivation Land Use Permit, has been set for the October 19, 2021, Departmental Agenda. On September 24, 2021, Planning and Development Department staff received additional comments from the Appellant to supplement their appeal application submitted May 17, 2021. In light of the supplemental comments, the Applicant is requesting to continue the item to December 14, 2021, to allow additional time to evaluate and respond to the Appellant's concerns. The Appellant and the Planning and Development Department support the Applicant's request for a continuance. A substantive Board Agenda Letter addressing the May 17, 2021 appeal application and the September 24, 2021 supplemental comments will be docketed for the December 14, 2012 hearing.

A copy of the Applicant's request, provided via email dated October 6, 2021, is included as Attachment 1 to this Staff Memorandum.

As such, Planning and Development Department Staff recommends the Board of Supervisors continue the item to the Departmental Agenda for December 14, 2021.
