 - 1. Storm Damage Repairs on N. Jameson Lane Guardrail Repairs near Bridges BR-0341 (Romero Cr), BR-0342 (San Ysidro Cr), and BR-0343 (Oak Cr); County Project No. 18114P, Federal Project No. ER-38MO(002), First Supervisorial District;
 - 2. Storm Damage Repairs on Hot Springs Road; County Project No. 18115P, Federal Project No. ER-38MO(005); First Supervisorial District.
- b) Determine the above projects were found by the Board to be exempt from the provisions of the California Environmental Quality Act and that the Director of Public Works or designee was authorized to advertise for bids to construct these projects on November 6, 2018. A Notice of Exemption was filed on this basis on September 26, 2018, and the proposed action is within the scope of the above reference Notice of Exemption.

Background:

The Thomas Fire Debris flow on January 8, 2018 caused extensive damage to the County's transportation network within Montecito, Summerland and Carpinteria.

18114P: N. Jameson Guardrail Repairs

This project included bridge approach railings, concrete railings, clearing of drainage inlets; replacement of asphalt dike, and asphalt drainage swales.







18115P: Hot Springs Road

This project included replacement of drainage inlets, replacement of asphalt dike, construction of concrete and asphalt drainage swales, and roadway resurfacing.
