BE IT RESOLVED by the County Board of Supervisors of the County of Santa Barbara as follows:

A. The County Board of Supervisors has reviewed the State of California's Community Development Block Grant – Disaster Recovery (CDBG-DR) Action Plan for 2017 disasters and hereby approves the execution of a Standard Agreement ("Agreement") between the County of Santa Barbara("Subrecipient") and the California Department of Housing and Community Development ("HCD"), allocating to the County the aggregate amount, not to exceed, \$5,378,130 ("Grant") for the following HCD CDBG-DR Programs:

2017 Disaster Recovery Infrastructure Program: \$5,378,130

The County Board of Supervisors agrees to perform activities, as further detailed in the Agreement, as a means to facilitate the development of infrastructure pursuant to the 2017 Disaster Recovery Infrastructure Program (DR-Infrastructure) Policies and Procedures, as the same may be amended from time to time.

- B. The County hereby authorizes and directs the Director of the Public Works, or designee, to enter into, execute and deliver the Agreement and any and all subsequent amendments thereto with the State of California for the purposes of the Grant.
- C. The County acknowledges compliance with all state and federal public participation requirements in the development of its application(s).
- D. The Director of Public Works, or designee, is authorized to execute and deliver all project applications and any and all related documentation required to effectuate the terms of the Agreement, and to act on the County's behalf in all matters pertaining to all such applications and documentation.
- E. If an application is approved, the Director of Public Works, or designee, is authorized to enter into, execute and deliver the Agreement, as well as the Notice to Proceed, and any and all amendments thereto with the State of California for the purposes of the Grant.

F. If an application is approved, the Director of Public Works or designee, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the Agreement for purposes of the Grant.
