That the Board of Supervisors:

- a) Authorize and direct the Clerk of the Board to release the monument deposit set in the amount of \$17,420 paid by bond number SAIFSU0666150, that was posted to guarantee the payment of the cost of setting of the interior monuments for Final Map Tract No. 14,768, pursuant to Government Code Section 66496 of the State Subdivision Map Act; and

Summary Text:

This item is on the agenda in order to release the monument deposit for Final Map of Tract No. 14,768. On December 8, 2014, the Board of Supervisors approved the Boulders – Park Hill Estates V.2, Final Map of Tract No. 14,768, (APN's 059-290-041 and 059-030-033), located at 4700 Via Los Santos, in the Goleta Area, Second Supervisorial District. On December 8, 2014, the Board also approved the deposit amount of \$17,420 required for the cost of setting of the interior monuments for the Final Map of Tract No. 14,768.

On March 5, 2015, the Clerk of the Board of Supervisors received that \$17,420 deposit in the form of a bond. On April 2, 2015, the Final Map of Tract No. 14768 recorded. On April 14, 2021, Jose Cardenas, the surveyor for Tract No. 14,768, certified that all interior lot corners have been installed and that he has been paid for his work and the Certificates of Correction to Tract Map No. 14,768 that recorded on February 25, 2021 and September 20, 2021. The monument deposit is no longer required pursuant Section 66497 of the State Subdivision Map Act.

The monument deposit for Tract No. 14,768, in the amount of \$17,420 was approved by the Board of Supervisors on December 9, 2014, and received by the Clerk of the Board of Supervisors on March 5, 2015 (Bond Number SAIFSU0666150).
