That the Board of Supervisors:

- a) Adopt a resolution that duly authorizes the Public Works Director, or Director's designee, to consent to requests to substitute subcontractors and, when a written objection is filed by the listed subcontractor, to preside over hearings to consider the substitution of subcontractors pursuant to California Public Contract Code Section 4107; and
- b) Find that the proposed action does not constitute a "Project" within the meaning of the California Environmental Quality Act, pursuant to 14 CCR 15378 (b)(5), in that it is a government administrative activity that will not result in direct or indirect changes in the environment.

That the Board of Directors of Laguna County Sanitation District:

c) Adopt a resolution that duly authorizes the Public Works Director, or Director's designee, to consent to requests to substitute subcontractors and, when a written objection is filed by the listed subcontractor, to preside over hearings to consider the substitution of subcontractors pursuant to California Public Contract Code Section 4107; and d) Find that the proposed action does not constitute a "Project" within the meaning of the California Environmental Quality Act, pursuant to 14 CCR 15378 (b)(5), in that it is a government administrative activity that will not result in direct or indirect changes in the environment.

- e) Adopt a resolution that duly authorizes the Public Works Director, or Director's designee, to consent to requests to substitute subcontractors and, when a written objection is filed by the listed subcontractor, to preside over hearings to consider the substitution of subcontractors pursuant to California Public Contract Code Section 4107; and
- f) Find that the proposed action does not constitute a "Project" within the meaning of the California Environmental Quality Act, pursuant to 14 CCR 15378 (b)(5), in that it is a government administrative activity that will not result in direct or indirect changes in the environment.

That the Board of Directors of the Santa Barbara County Water Agency:

Summary Text:

This item is on the agenda to authorize the Public Works Director or Director's designee to consent to requests to substitute subcontractors and, when a written objection is filed by the listed subcontractor, to preside over hearings to consider the substitution of subcontractors pursuant to California Public Contract Code Section 4107.

Background:

The "Subletting and Subcontracting Fair Practices Act" as codified in California Public Contract Code §4100 et seq., is intended to prevent bid shopping and bid peddling in connection with the construction, alteration, and repair of public improvements. This law requires prime contractors to list in their bids subcontractors performing an amount in excess of one-half of 1 percent (0.5%) of the prime contractor's total bid (or in excess of \$10,000 if transportation related work). Listed subcontractors may not be substituted except for certain reasons as enumerated in §4107. This action duly authorizes the Public Works Director, or designee, to consent to requests to substitute a subcontractor. Prior to such consent, the listed subcontractor has the opportunity to file a written objection to the requested substitution, which would trigger a hearing on the request for the substitution. This action authorizes the Public Works Director, or designee, to act as the hearing officer at any subcontractor substitution hearing that may be necessary as related to any Public Works Department contract including those under the Laguna County Sanitation District, the Flood Control and Water Conservation District and the Water Agency.
