I am writing you today to remind you of your place. You are an elected board, not an appointed or inherited one. This means you can be unelected. You are not my lord, I am not your subject or serf, I do not serve you, you serve me. You have been derelict in your duties in our county. You have allowed public health to determine rules for us based on control, not on science, and it MUST STOP NOW. The people have had enough.

The claim is that all of your mandates filtered through public health are based on science. Let's start with masks. I did some research. According to one study: "Invasion of particles with cloth masks was almost 97% and 44% with medical masks. Analysis revealed significant higher influenza like illness (RR=6.64, 95% CI 1.45-28.65) and laboratory confirmed virus (RR=1.72,95% CI 1.01-2.94) in the cloth mask group as compared to the medical mask group. ...Both surgical mask and cotton mask were ineffective in preventing the spread of SARS-COV-2 with a reported median viral loads of 2.42 log copies/ml and 1.85 log copies/ml after cough by infected patients with surgical mask and cotton mask respectively." The link for this study is https://www.ncbi.nlm.nih.gov/pmc/articles/PMC7497125/ if you wish to look at it for yourselves. Mind you when medical professionals wear masks, they are trained in the correct procedures and often have fitted n-95 masks. The way most people wear them, ie touching them constantly, wearing them repeatedly with no cleaning between, dropping them and putting them back on, is not effective and safe and actually can lead to other infections. In other words, mandating masks isn't zero risk and can actually cause harm while at the same time not granting any benefit. This doesn't even touch the drop in oxygen several have demonstrated to happen or the psychological damage this is causing, particularly to our children.

I will go on to say that the segregation of our children within the school system in Santa Barbara County must stop. You just read that masks, particularly as they will be used by children, will do nothing to decrease transmission, but lets talk about viral load between vaccinated and unvaccinated. First you must recognize that far more individuals than you have records of have had covid and recovered in our county. Why is this? Well particularly during surges of infection, families were instructed not to test ALL family members as the system was overwhelmed. They were instructed that if one person in the household tested positive and others had symptoms to treat that as a positive. I know this is what my family was told. There are 5 of us and we only had one official positive test yet all 5 of us have antibodies. This likely means that for every positive test on record there are likely 3-4 more that went unrecorded. No studies have been done on viral loads of unvaccinated and recovered from covid versus vaccinated, however there have been several studies between strictly unvaccinated and vaccinated and the conclusion has been that the viral load is equal in both groups if not higher in the vaccinated group. According to a Yale study, "A total of 869 samples, 500 from HYT and 369 from UeS, were included in the analysis. All analyzed samples from HYT were asymptomatic at the time of collection and 75% of the positive samples were from unvaccinated individuals

(N=375). Positive samples from UeS were from both symptomatic (N=237) and asymptomatic individuals (N=132). The frequency of vaccine breakthroughs among the UeS samples (171 fully vaccinated, 198 unvaccinated) was greater than among the HYT samples, reflecting the different types of populations sampled. The Delta variant was the predominant variant detected in both populations (Supplementary Table 1).

There were no statistically significant differences in mean Ct-values of vaccinated (UeS: 23.1; HYT: 25.5) vs. unvaccinated (UeS: 23.4; HYT: 25.4) samples. In both vaccinated and unvaccinated, there was great variation among individuals, with Ct-values of <15 to >30 in both UeS and HYT data (Fig. 1A, 1B). Similarly, no statistically significant differences were found in the mean Ct-values of asymptomatic (UeS: 24.3; HYT: 25.4) vs. symptomatic (UeS: 22.7) samples, overall or stratified by vaccine status (Fig. 1B). Similar Ct-values were also found among different age groups, between genders, and vaccine types...In all groups, there were individuals with low Ct-values indicative of high viral loads. A total of 69 fully vaccinated individuals had Ct-values <20. Of these, 24 were asymptomatic at the time of testing."

Studies are showing no difference in viral load between vaccinated and unvaccinated, symptomatic or asymptomatic. Despite the scientific evidence, you allowed our public health to make rules that segregate our children in school. Those that are vaccinated may stay in class if exposed despite evidence that they will shed the virus in high quantities. While the unvaccinated must quarantine or modify quarantine. You are also segregating staff. Those unvaccinated must test, while those that are vaccinated can freely participate in work without testing. Even though their likelihood of spreading it is equal. So truly these rules aren't protecting anyone. They are pushing an agenda based on control and fear mongering. Pushing and pushing parents driven by fear to vaccinate their children. Despite the fact that COVID basically does nothing to healthy children, while the vaccine has left thousands of children with a death sentence. 

Mandatory Masking of School Children is a Bad Idea

California health officials have mandated masks for all students when schools reopen on the grounds that "treating all kids the same will support a calm and supportive school environment."

There is a much better way to achieve the same goal: discontinue mask wearing for all students, vaccinated or not.

The benefits of masks in preventing serious illness or death from COVID-19 among children are

infinitesimally small. At the same time they are disruptive to learning and communicating in classrooms. They may be partially effective in shielding adults from COVID, but since when is it ethical to burden children for the benefit of adults?

COVID-19 is less of a threat to children than accidents or the common flu. The survival rate among American children with confirmed cases is approximately 99.99%; remarkably, recent studies find an even higher survival rate.

A Centers for Disease Control and Prevention study estimated that mask mandates in schools are associated with a roughly 20% reduction in COVID-19 incidence though the effect estimate was statistically indistinguishable from zero. Let's take the 20% effect at face value and do the math. Last month, about 5,000 school age children in California were diagnosed with COVID-19, which means 1,000 infections would have been prevented if all school kids wore masks. Given the survival rate among children, mask mandates might prevent one child death in the coming school year, a tiny fraction of the approximately 900 deaths of children 5 to 17 years old in 2019. If the aim is to save children's lives, other interventions – like enhanced pool safety – would be much more effective.

At the same time, the long-term harm to kids from masking is potentially enormous. Masking is a psychological stressor for children and disrupts learning. Covering the lower half of the face of both teacher and pupil reduces the ability to communicate. In particular, children lose the experience of mimicking expressions, an essential tool of nonverbal communication. Positive emotions such as laughing and smiling become less recognizable, and negative emotions get amplified. Bonding between teachers and students takes a hit. Overall, it is likely that masking exacerbates the chances that a child will experience anxiety and depression, which are already at pandemic levels themselves.

So why are adults insisting on masking school children? The argument that it treats all children the same is misdirection. Put simply, it is about self-preservation. Children may not be particularly vulnerable, but they can spread the virus to others, including teachers, school staff, and family members, some of whom may be vulnerable.

The fear of transmission was so great last year that even masking was not enough. Schools were closed en masse, sacrificing a year and a half of childhood development to keep adults safer. Ironically, the evidence from my.research and those of others suggest that the effects of school closures on COVID-19 risk were at best minimal. In Sweden, where schools were not closed, and children were not masked, teachers were at lower COVID-19 risk than the rest of the population. Closing U.S. schools was a mistake as the harm to children likely exceeded the small benefit to adults.

Today, adults have no reason to put their safety ahead of the well-being of school kids. Vaccinations are highly effective at keeping adults out of the hospital and even better at preventing death. A healthy, fully vaccinated teacher is close to impervious to threats posed by COVID-19 spread in the classroom. By now, every teacher in America has been offered the vaccine; many were in the first priority group, even above vulnerable older people. If we want to enhance safety for adults further, we can do so by other measures, such as improved ventilation, that are less intrusive than masking.

Parents who are not vaccinated have it backwards if they count on their children to not bring COVID-19 home. They need to step up and be the first line of defense for their families.

Ethically, the onus is on proponents to show that the benefits of masking kids outweigh the costs. They are proposing a fundamental, risky shift in classroom interactions and should prove with certainty that there are no other options for safely reopening schools.

The California Department of Health and Human Services has no such proof. Instead it is demanding another year of diminished education and personal growth for children so that adults can feel marginally safer, even with massively effective vaccines available.


My comments are as follows:


