Summary Text:

The attached letter from the Lompoc Veterans Memorial Building Foundation (Foundation) was received by the General Services Department on July 29, 2010. The letter requests that the County contribute \$50,000 toward the Lompoc Veterans Memorial Building Roofing Project.

The Foundation has been working diligently for the past few years to raise the necessary funds to perform a variety of deferred maintenance and renovation projects at the Lompoc Veterans Memorial Building. The Foundation received a \$255,000 grant from the Wood Claeyssens Foundation specifically for this roofing project. The total cost of the roofing project is estimated to be \$400,000.

Background:

The General Services Department is working collaboratively with the Lompoc Veterans Memorial Building Foundation to restore the Lompoc Veterans Memorial Building. As such, on September 10, 2007 a condition assessment of the building was completed by a local architect. The assessment identified many areas of the building that were in need of improvement and repair, one area being the roof and associated roofing elements (i.e., gutters and downspouts). The total cost of all of the improvements and repairs indentified in the assessment report is over \$3 million. The Foundation was created for the purpose of raising the necessary funds to complete all of the repairs listed in the assessment report and renovate and enhance the building for the continued use by the Veterans, the County, and the Lompoc Community.

Fiscal and Facilities Impacts:

Should the Board elect to contribute the requested \$50,000, staff recommends that the attached budget revision be adopted that allocates the funds from the Fiscal Year 2010-11 Capital Designation.

As you are aware, bids were just received for the re-roofing the Lompoc Veterans Memorial Building. The low bid came in at \$328,000 which exceeds the \$255,000 grant which the Foundation received from the Wood Claeyssens Foundation. THE LANGE LINE TREETON DESIGNATION OF THE PART

As we discussed, the ownership of the Lompoc Veterans Memorial Building still lies with the County of Santa Barbara. Our Foundation was established for the sole purpose of renovating the building. When the restoration is completed, a decision will need to be made as to how the building will continue to operate.

In the meantime, we feel that the County of Santa Barbara should continue to serve in a partnership with the Lompoc Veterans Memorial Building Foundation and provide funds toward the renovation of the building; we are therefore requesting that the County of Santa Barbara provide \$50,000 toward the re-roofing project. Had not the Foundation been established and received grant funds, the County of Santa Barbara would have been responsible for funding the entire \$328,000 for the reroofing project since it was crucial that the re-roofing project be completed.

Members of the Foundation are enjoying being a part of this restoration project and appreciate the County allowing us to participate in this partnership. We respectfully urge the County of Santa Barbara to provide this \$50,000 toward the re-roofing project. ing in garja dang terbelah lang beber
