- e) Adopt a Resolution and Ordinances amending the Comprehensive Plan Land Use Element and Article III Zoning Ordinance text and maps, Case Numbers 00-GP-004, 00-OA-006, and 00-RZ-003;
- f) Adopt a Resolution amending the Circulation Element, Case Number 01-GP-002;
- g) Adopt Findings and Statement of Overriding Considerations supporting the Board's final action in adopting the Toro Canyon Plan.
