c) Approve and authorize the Chair to execute a Contract with Community Action Commission of Santa Barbara County (a local vendor) in the amount of \$113,731.00 for the period October 1, 2011 through July 5, 2012 to provide WIA Youth Services to Out-of-School eligible youth between the ages of 14-21 years of age in Santa Barbara and Carpinteria; and

d) Approve and authorize the Chair to execute a Contract with Henkels & McCoy Training Services (not a local vendor) in the amount of \$236,269.00 for the period October 1, 2011 through July 5, 2012 to provide WIA Youth Services to Out-of-School eligible youth between the ages of 19-21 years of age in Lompoc and Santa Maria.
