- a) Approve and execute and agreement with Casa Serena, Inc. (a local vendor) for alcohol and other drug residential and outpatient treatment services for a maximum contract amount of \$144,500;
- b) Approve and execute and agreement with Family Life Counseling Services (a local vendor) for alcohol and drug treatment services for a maximum contract amount of \$124,475;
- c) Approve and execute and agreement with Mental Health Systems (not a local vendor) for Substance Abuse Treatment Court (SATC) and Substance Abuse Crime Prevention Act (SACPA) alcohol and drug outpatient treatment services for a maximum contract amount of \$350,753.
- d) Authorize the Director of Alcohol, Drug, and Mental Health Services to approve amendments to the proposed contracts, providing that any such amendments or modifications do not exceed ten percent (10%) of the total contract value.
